


# ECCL Report: April 12, 2019

**Executive Summary:** 182nd meeting of the Estero Council of Community Leaders



County staff is proposing the deletion of Map 14, the Future Limerock Mining Overlay, along with regulations that govern and direct new mining operations that protect our quality of life. In 2010, Lee County successfully defended Map 14 and its supporting policies in court. The only thing that has changed since then is the leadership. Please let the County Commissioners know that you oppose the deletion of Map 14 by

attending the BOCC meeting on April 17.

Village Report: The Village has been hard at work this year and their 2019 accomplishments so far include purchasing the Estero on the River property, receiving an 87% recovery rate from FEMA on hurricane recovery funds, completing the Stormwater Master Plan, being 90% complete with Estero Parkway renovation design, and working on the Parks and Open Space and Bike-Ped Master Plans.

Education Outreach Council: The "Breaking Par at Grandezza" fundraiser event was a huge success. Since 2013, the event has raised more than \$382,000 for Junior Achievement. The 2-58-Graduate program has completed all JA 2018-2019 classes and all volunteers remain committed to the program. The Institute for Entrepreneurship mentor program is at maximum capacity and Lee County School volunteer recruitment efforts are currently on hold.

**Lee Health Coconut Point Update:** The ECCL Health Committee is helping LHCP establish a Guest Advisory Committee with Lee Health doctors, nurses, and administrators to improve services and implement new programs.

London Bay / "Weeks Fish Camp" Property: The application review is being held up by an unrelated Bonita Springs Comprehensive Plan amendment. Sufficiency (application completion) is not expected for 6 to 9 months and CCRC is in the approval process. The developer has made significant improvements to the proposed marina, including better traffic flow, increased onsite trailer parking, improved kayak launching area, and better-defined offsite parking.

**ECCL Board Update:** The Board selected the ECCL's vision statement, strategic pillars, and core values. They also approved exploring the viability of a joint Village/Chamber/ECCL Estero Forever Fund, creating a new website, and continuing audio/video recordings of meetings.

**Estero Fire Rescue:** EFR has run into some challenges while building Station 5 (East Corkscrew Rd). The location provided is too close to the Lee County Wellfield wells and a new location is required. Approvals and permits are currently working through the system.

The next ECCL meeting will be Friday, May 10, 2019 at 10:00am at Estero Community Park.

#### **ESTERO FIRE RESCUE**

- Jack Lienesch, Estero Fire Rescue Board
- Challenges of Building EFR Station 5 (East Corkscrew Rd)
  - 5 acres provided by the developer are too close to Lee County Wellfield wells.
  - New location is required.
  - Approvals and permits are currently working through the system.
  - In 1 year, there should be a temporary set-up building and then, ultimately, a permanent fire station.

#### VILLAGE REPORT

- Village Councilmember Update
  - 3 current councilmembers will term limit out in 2 years: Nick Batos, Howard Levitan, and Bill Ribble.
  - Please get involved in our local government.
- Village's 2018 Accomplishments (Thanks to Village Leadership & Staff)
  - Lowest tax rate in Southwest Florida
  - Successful government light operations with only 11.5 employees (8 full-time)
  - Highest per capita reserves
- Village tax rate is only 5% of your Lee County property tax bill
- Village's 2019 Accomplishments So Far

- Purchase of 62.2-acre Estero on the River property Total purchase price was \$24.5m or \$394k per acre.
- This compares favorably to local purchases by Lee Health (\$407k/acre) and Hospital Corporation of America (\$525k/acre).
  - Staff Working with FEMA on Hurricane Recovery Funds
    - The Village received \$200k of the \$230k submitted for reimbursement.
    - That's an 87% recovery rate, which is the maximum rate available.
    - The Village owes Lee County \$100k for Irma clean-up.
  - Completed Stormwater Master Plan
    - Two rain events in August/September 2017 revealed flooding in the streets (as they are designed to flood in a major rain event) and little flooding to homes.
    - Master Plan provides modeling to review changes as a result of development.
    - Sheet flow analyses were considered within and outside the borders of Estero as both affect homeowners.
    - Ongoing maintenance of natural drainage systems & communities continually cleaning their storm sewer pipes will help.
    - The Village met with gated & non-gated communities to review their community stormwater plans.
    - In anticipation of this hurricane season, 3 efforts are ongoing:
      - Village cleaning the ditches on West Broadway.
      - Lee County working with Marsh Landing & Fountain Lakes developments to clear any obstructions within Halfway Creek.
      - SFWMD clearing Mullet Creek west of the Vines Community
    - The Village also replaced the culvert on Broadway.
  - Estero Parkway Renovation
    - Renovation design will be 90% complete in a few days and ready to send RFPs to potential bidders.
    - Plans include all aspects of the project: road resurfacing, bike lanes, multi-use path, landscaping, and street lights.
    - Work is expected to begin in July or August.
    - Construction will take 6-9 months, depending on weather.
  - Village Development
    - Lee Health Coconut Point, with the potential of an 80-bed hospital; Genova (205 condos); Estero Grande (180 apartments on 41 and Estero Pkwy); Spring Hill Marriott; Primrose Day Care (behind Culvers); Cube Smart (in front of Del Webb community); and retail next to Chase Bank (Miromar).
  - Parks and Open Space Master Plan & Bike-Ped Master Plan
  - Thank you to the community for all of the interest in these efforts.
  - Councilman McClain hopes the ECCL continues to be a critical player in these processes.

## LEE COUNTY DR/GR

- Julianne Thomas, Conservancy of Southwest Florida
- Potential Elimination of Map 14
  - Map 14, generally known as the Future Limerock Mining Overlay, was created by balancing the need for mining and compatibility with natural resource protection and residential neighborhoods.
  - Lee County staff now proposes deletion of this map, along with regulations that govern and direct new mining operations that protect quality of life.
  - Map 14 was litigated in 2010, when it was challenged by mining companies.
  - Lee County defended the map at that time and its supporting policies were determined to be clear and unambiguous.
  - Nothing other than leadership in Lee County has changed, but the map and supporting policies are now at risk.

Please let the County Commissioners know that you oppose the deletion of Map
 14 by attending the BOCC meeting on April 17.

  - The application review is being held up by an unrelated Bonita Springs Comprehensive Plan Amendment.
  - Sufficiency is not expected for 6 to 9 months.
  - CCRC is in the approval process.
  - The developer was engaged and made significant improvements to the proposed marina, including better traffic flow, increased onsite trailer parking, improved kayak launching area, and better defined offsite parking.
  - Developer needs the ECCL to help sell the plan, which is looking more like the Lovers Key boat ramp every day.
- CPA2018-10008, Old Corkscrew Commercial
  - There are inconsistencies with Lee Plan.
  - Are commercial services actually necessary at this location?
  - Spot Zoning Does the approval of a single 18-acre parcel for a commercial use in the middle of the DR/GR area constitute "spot zoning?"
  - Does this establish a precedent for additional commercial projects in DR/GR?
