

ECCL Report: December 14, 2018

Executive Summary: 178th meeting of the Estero Council of Community Leaders



Finance Committee: In November, the ECCL received its first digital marketing income from their first client, Lee Health. Expenses were a bit higher than normal in the month, resulting in a small loss for November. Complete financial statements are linked to the agenda. Members should expect to receive invoices for dues in the near future.

Education Outreach Council (EOC): On December 4, the ECCL's EOC sponsored a celebration for over 100 Estero school teachers, administrators, and the volunteer Junior Achievement teacher ambassadors with complimentary snacks, soft drinks, wine, and beer provided by The Club at Grandezza. The 7th Annual Breaking Par at Grandezza is also coming up on March 21 with a Gala Dinner at 5:30pm and a live and silent auction followed by a Golf Tournament on the following day. All net proceeds will benefit Junior Achievement of Southwest Florida (K - 12) educational programs as well as being the predominant funding for JA's flagship program, CEO Academy at FGCU. Health Committee: Lee Health Coconut Point is now open and the open house was a huge success with over 4,500 people coming out to support the new center. The American Heart Association's Heart Walk (scheduled for March 2) is now being planned as a Heart Health Fair. Beginning January 15, Estero residents are encouraged to participate in the Healthy Lee's Million-Mile Movement where people all over Lee County will try to create more movement through walking, swimming, running, and more. Lastly, the Estero Health and Wellness Fair, jointly sponsored by Lee County and Lee Health, is coming up on Saturday, January 26.

Environmental Committee: On December 17, the Lee County Local Planning Agency (LPA) will hold a meeting to review a County Comprehensive Plan proposal. The proposal would delete the existing Future Limerock Mine Overlay that limits mining in the DRGR area to properties along Alico Road and many other standards that protect the residents of the area as well as

impacts on our water quality and supply and threatened wildlife. This proposal will allow the mines to locate anywhere in the DRGR with no regard to the public.

Village Report: The Village's initial comprehensive Capital Improvement Plan (CIP) – that covers the funding of 21 projects over the next 5 years and 15 projects after that – has been approved. Estero's first truly Estero Comprehensive Plan was approved by the State of Florida but has been contested by one developer/property owner. A Storm Water Master Plan is being developed to better understand the water flows and flood prone areas within the Village. A consultant has been retained to help with the preparation of a Village-wide Bicycle and Pedestrian Master Plan. Also, a Parks, Recreation, and Open Space Master Plan has just commissioned by the Village. Finances for the Village this year have been excellent. The Village was able to reduce its property tax levy for the third year in a row. There are also many major developments in the works in the Village.

ESTERO FIRE RESCUE

- Fire Chief Scott Vanderbrook
- Chief Vanderbrook just completed his 20th year with Estero. Thank you!
- Property Update
 - The Estero Fire Rescue (EFR) just purchased the 4.6 acres behind their administrative building and they are hoping to close on that January 9.



- That property will be used for additional parking and covered parking for the expansion at the administration building.
- EFR will be participating in the Heart Walk.
 - It will take place at Lee Health Coconut Point on March 2.
- This month has been a deadly month for this country due to home fires.
 - Please check your smoke detectors and be sure they are working correctly.
- Is there anything the public would like to hear from the EFR?
 - Please reach out with any requests at any of the coming meetings.
- What is the protocol for the Lee Health Facility?

- Ambulances are taking people to D-31 (Lee Health Coconut Point). The only type of patient that cannot be accepted there is a trauma case, which must be taken to D1 (Downtown Location where the trauma facility is located). If a person must be admitted after 24 hours, they can be transferred to another facility.

Should people get carbon monoxide detectors?

- Yes! This is especially important for pre-cranking cars. The best places to put them are near the garage and in the kitchen.

Is there anyone still in the Panhandle?

- No, everyone has returned. They have also started the process through FEMA to get the reimbursement. It takes a year to process. They still haven't gotten their reimbursement from Hurricane Irma.

Is there any transit you can report on members and calls?

- No. The EFR started the year with 26 calls in one day. Normally, out of season they average 12-15. The call volume doubles at the beginning of the year, especially with the growth coming.
- This is why the EFR is planning their 20-year expansion plan.

VILLAGE REPORT: ANNUAL REPORT

Capital Improvement Plan

 The Capital Improvement Plan (CIP) was approved and covers 5 years of future funding for 21 projects in the 5-year window and 15 more projects after that.



Comprehensive Plan

- Estero's Comprehensive Plan was approved by the State of Florida and its sections are as follows:
 - Community Profile, Vision, Future Land Use, Transportation, Housing, Infrastructure, Conservation, Coastal Management, Recreation, Open Space, Inner Governmental Cooperation, Capital Improvements, Public School Facilities, & Monitoring
- The plan has been in the process for over a year and included over 20 meetings.
- The next step for Estero is to implement a Land Development Code, which will be the details of how we continue to develop the Village. That should be finished in Fall 2019.

Storm Water Master Plan

- This plan is being created to understand the water flows not only within the Village boundaries, but also around us.
- This will help us understand and reduce flooding. It will finish in the first quarter of 2019.

Bicycle and Pedestrian Master Plan

- Being funded by the MPO. The completion date is unknown.

CSX Railway

- The Village has had preliminary conversations with the CSX Railway.
- The long-term goal is for the Village to have some sort of trail that runs through Estero into Bonita.

Parks & Open Space Master Plan

- Focus groups will be invited in the first quarter of 2019 to begin development.
- The Village Manager and the Mayor met with the State Parks Committee in Tallahassee about a possible partnership for Koreshan State Park and they are eager to begin that process.



Finance Report

- The Estero Village reduced the tax levy for the third year in a row.
- Estero has the lowest tax rate of any of the cities in the SWFL area.
- As a part of the new Village Budget, the Village made a commitment of \$1.6 million allocation to increase operating reserves, which now totals \$5.1 million (equivalent to 10 months of operating expenses if we are faced with another economic downturn or disaster).
- Estero's finances remain strong.
- Estero's Finance Director is receiving the highest award from the National Finance Association for the second year in a row.
- There are two other reserves established: one for litigation and defense for major law suits and one for road maintenance.
 - The road maintenance reserve was just established with a 17-year plan for all roads received by the county.
- New Estero reserve policy: All reserves are more protected. It now takes 5 votes rather than 4 votes on the Village Council to make any changes to these reserves
- Estero took over the 29 streets from Lee County and is now saving about 1 million dollars to perform work ourselves.
 - Using this money, the Village hired David Willems to oversee all the Village's road and water projects.

- Tidewater near Estero Parkway & Ben Hill Griffin Parkway: 55+ community with about 800 homes
- The Shoppes at Estero Grande: An affordable apartment project behind Estero Grande
- The Village has approved many hotels:
 - The Hilton Garden with 120 rooms
 - Coconut Square
 - No name hotel near I-75

- Springhill Suites with 100 units
- Adera Apartments: 180 units
- Argo Office Complex: 5 stories and 66 thousand square feet of space
- Shoppes at University Highland: Chase Bank, Tide Cleaners, Starbucks
- 2 senior living centers:
 - Phoenix Project
 - The Volunteers of America Senior Living Center

• The 62 Acre Land Purchase

- This will hopefully be closed on January 12.
- It looks like it will get reasonable rates.
- Once it's closed, there will be a financial planner hired for planning.

Roads and Landscaping

- The Estero Parkway design is finally done. Lighting will be included in the plan.
- The US 41 lighting program is completed.
 - The State has also approved landscaping for US 41 with a \$700,000 budget and the Village will assume maintenance after it's done.



- Because the speed limit is 50 instead of 45 on this road, we cannot plant trees in the median.
- Williams Road will get turning lanes at Estero High School.
- The new stop light at the intersection at the Hertz Arena access road at Ben Hill Griffin Pkwy was approved.
- The Village has awarded the job of developing a brand for Estero and will be working with a consultant on that task.
- The Village is working with the state to install a traffic light at US 41 & Pelican Colony Dr.
- I-75's Exit 123 at Corkscrew Road will be improved with double turning lanes and the project will be state funded.

• Inner Governmental Relations

- Lee County Board of Commissioners
 - Approved the Corkscrew Road design and approved moving the project to a Tier I priority.
 - Plan to acquire land in the eastern Alico corridor to create new roads to alleviate mine hauling traffic on Corkscrew.
 - Approved interim improvements on the entry to Corkscrew Road at Pinewood School and The Preserve at Corkscrew.
- Lee County School Board Task Force
 - The mentoring internship program has yielded good results.

- There are plans to share the school grounds with the community when they aren't in use.
- They're establishing a student assignment program that sets attendance priorities for those students that reside in the Village so that they can attend the schools nearest them instead of being bused miles away to Fort Myers schools.
- Working with Lee County Utilities to develop approaches for dealing with failing septic tank issues.
- The Estero Chamber and the Village have entered in to a public private partnership, assisting the Chamber to get a new Executive Director with economic development experience.
- There is also a new task force team lead by the Chamber with 12 members to work on economic issues.
- The Village hosted two community events this year, including the 3rd anniversary party in March and the more recent Veterans Day Celebration.
- In recent news, the Village passed the gas pump anti-skimming law that requires new locks at gas pumps.
- At the December 12 meeting, the Village Council adopted a resolution urging the Board of County Commissioners to not take Don Eslick's name off of the Don Eslick Bridge over I-75.
- Lee Health Coconut Point is a valuable health addition to Estero, added this year.

- The Board of Directors sent out a call to action to do these three things:
 - 1. Attend the Board of County Commissioners meeting on December 18 in Fort Myers at 9:30am.

 - 3. Asking for signatures on a petition to leave the name of the bridge unchanged.
 - It has been live for less than 48 hours and already has 600 signatures.
- Linda Tecco-Roach made an official motion for a resolution by the ECCL supporting that the Estero Parkway bridge over I-75 continue to be named after Don Eslick. A vote was taken and it was unanimously approved by those present and signed by all directors for presentation to the Lee County Board of County Commissioners.

• Proposed Lee Plan Amendment

- Proposed to be deleted by County Administration Staff:
 - Requirement for limerock supply inventory and demand analyses
 - Requirement for future limerock mines to be designated on Map 14
 - Map 14, the Future Limerock Mining Overlay



- At the Lee County Local Planning Agency (LPA) meeting on December 17, the board members decided to delete the requirement of a periodic limerock needs assessment study but retain Map 14 of the Lee Plan, which shows where mines can be located. They said County Staff didn't give sufficient reason why it should be deleted. They asked staff to rewrite the amendment, knowing the board members' sentiments, but with a clear way to ADD future mine locations to Map 14. They also requested some ambiguous language to be cleaned up. This will be considered again at the next LPA meeting on January 28, 2019.
- Mr. Cangialosi summarized the following about this issue:
 - There are two proposed new mines (Troyer and Old Corkscrew) that are going through the re-zoning process.
 - Mining interests want to place mines outside of the currently-authorized Map 14 locations.
 - County is trying to delete important restraints on mining.
 - The whole point of the restraints in the Lee Plan is to keep mines from being placed near housing and neighborhoods. If these restraints were to be deleted, it could lower property values and give much less protection to the community from problems associated with mines.
 - A current study shows sufficient rock in the area the mines are already located that can carry all 7 counties until 2050, so there is no necessity for these restraints to be deleted.
