

# ECCL Report: October 12, 2018

**Executive Summary:** 176th meeting of the Estero Council of Community Leaders



Village Report: Roadway improvements on Estero Parkway are expected to start in April or May 2019. The Hertz Corporation has been asked to present a new proposal for painting the Hertz Arena. The Village Council voted to join the other 5 Lee County municipalities in an effort to change the Lake Okeechobee Water Release schedule in order to improve coastal water quality and tourist economy. Lastly, the Council is considering legislation that would cause Estero gas stations to protect their digital systems on gas pumps.

**Lee Health Coconut Point:** Lee Health Coconut Point will open December 3. It will have an open house on November 17 that will begin at 7:30am with a 5K walk/run. The festivities and tours will begin at 9:00am.

**Sanibel Water Contamination Issues:** The ECCL is supporting the Municipal Coalition seeking to have the SFWMD and Corp of Engineers assist in the fight of our water contamination problems. The Coalition is opposing the proposed Minimum Flow Level (MFL) policy update and proposing that updated real-time data is used to move forward.

**Proposed Development of the Former Weeks Fish Camp Property:** There is a Public Information Meeting scheduled for October 18 at 6:00pm at Estero High School on London Bay Properties' development proposal for this site. The ECCL encourages residents to attend to stay informed and make sure the developer knows how important we think a substantial public access marina is to Estero residents' quality of life. This site is our last opportunity to provide convenient public access to Estero Bay!

**Capital Improvement Plan (CIP) & Budget:** The Final 2018-19 Village Budget Meeting occurred on September 20. The operating budget and the Village's first Capital Improvement Plan, that included money for the purchase of the Estero on the River land, were approved.

**Estero on the River Property:** The purchase of the "Estero on the River" property has been approved and the purchase process is underway. The Purchase and Sale Agreement is scheduled for approval on October 24 with financing to follow and the closing scheduled for January 14, 2019. After the purchase closes, the Village plans to hire a consultant to manage the planning process for use of the property with public input.

**Estero Educational Outreach:** The EOC has a continuing need for volunteers for Junior Achievement, assistance with Estero's four public schools, and the Fall Program for the FGCU Institute for Entrepreneurship. Please consider signing up.

#### Estero Parkway

- Estero Parkway will be 1.8 miles long and include 7ft bike lanes to protect bikers.
- The Village Council will review in a Workshop on Wednesday, October 17.
- The project is projected to start in April-May and finish by the end of 2019.
- The lighting plan is still in the works. Councilman McLain asks for support on lighting the parkway and including lighting in the budget.

#### Hertz Arena

- Design Review Board received a presentation for the new design for the arena where a 100% yellow building was building proposed.
- Design Review Board asked for another proposal with less yellow.
- The design for the headquarters was not approved by the community.

#### Caloosahatchee Water Releases


- Sanibel Mayor Kevin Ruane approached the Council to support his initiative, which includes:
  - Maintaining the Caloosahatchee's estuary
  - Balancing salinity levels in the river
  - 6 new water monitoring systems along the river (already been implemented)
- We will be able to use this info to see if water levels are sufficient for the ecosystem and create new data for future standards.
- The Mayor is asking for a trial and to use the data to establish new standards.

- Estero Retail Pump Protection Plan
  - There has been an issue with credit card theft while paying by card at gas pumps.
  - The Village is working on developing an ordinance that will require all gas stations to incorporate the new locking devices on the pumps.
  - The locks will be unique to the station.

## SANIBEL: WATER CONTAMINATION ISSUES

- Sanibel's Director of Natural Resources, James Evans
- Supporting the Municipal Coalition Seeking SFWMD and Corp of Engineers to Fight Our Water Contamination Problems
- Concerns of the Proposed Minimum Flow Level (MFL) Policy Update:
  - Too Much Flow During Rainy Season
    - Lost 11,000 acres of lake and marsh storage
    - Lack of storage = no treatment
    - This can lead to an overgrowth of algae and strongly affect the area's economy and tourism
  - Too Little Flow During Dry Season
    - This can destroy critical habitat for manatees, fish, shrimp, and blue crabs
    - Can lead to different algae growing and affect sea life and the economy



- Low Flow
  - <450 cfs: High salinity in upper estuary causes mortality of tape grass habitat (data suggest 650 cfs).
- High Flow
  - >2800 cfs: low salinity causes mortality of marine organisms in seawards portion of the estuary.
  - >4500 cfs: low salinity in San Carlos Bay causes mortality of seagrasses.
  - >6500 cfs: low salinity plume enters Gulf of Mexico, adverse impacts on submerged aquatic vegetation and water quality in Pine Island Sound.
- \*Based on 30-day moving average flow at Franklin Lock (S-79)
- What is a Minimum Flow Level (MFL)?
  - MFL is the "limit at which further water withdrawals would be <u>significantly</u> <u>harmful</u> to the water resources or ecology of the area." (Section 373.042(1), Florida Statutes)
  - SFWMD defines significant harm as "the temporary loss of water resource functions which result from a change in surface or groundwater hydrology, that



takes more than two years to recover, but which is considered less severe than serious harm."

# Why Are We Challenging the Proposed MFL Update?

- The proposed rule is <u>less</u> protective than the 2001 rule (flow target vs. salinity target).
- Shifts the ecological baseline away from a sensitive ecological indicator habitat (i.e., tape grass) and averages it over several fewer sensitive indicators.
- Would result in higher dry season salinities and impacts to all organisms that depend on the low-salinity zone (0.5-6 psu).
- Hearing is Scheduled for October 29 & 30

# Village Comprehensive Plan

- Policy 1.2.1 discourage new public access to the Estero river for motorized watercraft.
- Policy 1.2.2 The Village will cooperate to the extent practicable with the City of Bonita Springs and Lee County to provide public access to the Estero Bay.
- This is our last opportunity to gain access to Estero Bay!



# SHOULD THE GERMAINE ARENA BE PAINTED "HERTZ YELLOW?"

- On October 3, the Design Review Board reviewed Hertz's proposal, which had been publicized by Hertz prior to the meeting.
- When the ECCL learned about the proposal, we sent out an email to our email list with renderings of the arena as Hertz would like to have it painted and asked the readers to tell the members of the Design Review Board (DRB) if they like



it or didn't like it. 437 people emailed the Design Review Board.

- 97% were opposed to painting the facility as Hertz had recommended
- About 100 people were at the meeting, only one spoke in favor
- Hertz hadn't consulted their architects about the design. Their branding and marketing department developed it.
- This was a preliminary information meeting. There will be two more meetings before a final decision is made.
- It was made clear to Hertz and the arena's owner that they would need to come up with a new proposal.

- Village of Estero Capital Improvement Plan (CIP) & Budget Update
  - Final Public Input Meeting, followed by CIP & Budget Adoption, occurred on September 20 at 5:30pm
    - The budget and the purchase of the 62 acres were approved.

    - Zoning is in process

- Pepperland Ranch: 700 units
  - Comp plan amendment approved
  - Zoning is approved

# Year 2045 Long Range Transportation Plan

- Long range planning is the responsibility of the Metropolitan Planning Organization (MPO)
- Mandated by the Federal Transportation Administration
- The MPO Mission Statement: "Our mission is to provide leadership and promote regional mobility, encourage a positive investment climate and foster sustainable development sensitive to community and natural resources."



#### MPO Board Members

- Lee County Board of Commissioners for all unincorporated areas
- Appointed member of incorporated municipalities is generally a council member

# Long Range Plan

- Every 5 years the current plan is updated, adding 5 years
- The next plan will cover 2020-2045 (25 years)
- The 2045 plan will be adopted by December 2020.

# • What Will Be Different? The 2045 Plan is Likely to be a Big Departure

- Vehicles have changed little in last 40 years
  - Powered by internal combustion engine
    - Carry 4 to 7 passengers
    - Require bigger roads as numbers increase
- Vehicles will change dramatically
- Experts like Daniel Sperling of U.C. Davis propose three big changes:
  - Electrification: Many electric vehicles are on the road today
  - Automation: First signs are crash avoidance and driver assist
  - Pooling (like Uber): The car in the garage is gone

- Junior Achievement Estero Schools Recruitment Progress Report Jim Shields
  - The Lee School Board has agreed to a curriculum where JA will be invited into the classrooms and be part of the curriculum for 2<sup>nd</sup> graders, 5<sup>th</sup> graders, 8<sup>th</sup>

- graders, and 11<sup>th</sup> graders at Estero-area schools. The programs will focus on work readiness, financial literacy, and entrepreneurship.
- Classes will be facilitated by team-teaching volunteer Estero Education
   Ambassadors recruited by ECCL Education Outreach Council leadership team.
- Volunteers:
  - 74% are current or former business leaders/owners
  - 26% are former career educators who want to return to the classroom.
- Junior Achievement Classes are included in school curriculum at all four schools: Pine Woods Elementary, Three Oaks Elementary, Three Oaks Middle School, and Estero High School



- For current school year 2018 '19 volunteer Estero Education Ambassadors will facilitate more than 60 classes involving separate 300 class-sessions.
- In 2019 Junior Achievement will celebrate its 100<sup>th</sup> Anniversary.
- **EOC Assistance to Pinewoods Elementary** Kevin Tolliver
  - Introducing the AVID Program
    - Advancement Via Individual Determination (AVID)
    - Program for children who have barriers to attending college (ex. potential first-generation college students)
    - Nick Batos is spearheading this initiative for the Village
    - Volunteers are needed for this program (currently have 25-30 volunteers)
- Fall Program for the FGCU Institute for Entrepreneurship (IFE) Bill Motzer
  - Three Programs
    - · Veterans program for mentoring
    - Runway program for helping students develop ideas
    - Program for students majoring or minoring in entrepreneurship.
  - Since 2017, this program has grown to 375 students with an increase in staff to mentor, teach, and direct the Program.
  - IFE recently announced plans to move to re-locate to main campus once funds have been secured to make that possible.
