

# ECCL Report: February 8, 2019

**Executive Summary:** 180th meeting of the Estero Council of Community Leaders



Proposed Changes in DR/GR Mining Rules: The Board of County Commissioners is considering an amendment to the Lee Plan that will allow fast-track approvals of widespread DR/GR mining applications. Mining can cause water quality and flooding issues and additional truck traffic on the already overloaded Corkscrew Rd. Please attend the County Commissioner Hearing on February 20 and contact the Commissioners to voice your concerns.

**SWFL Heart & Wellness Festival:** The American Heart Association is hosting its annual SWFL Heart & Wellness Festival and Heart Walk on Saturday, March 2 at Lee Health Coconut Point. The event will include an optional 1-mile non-competitive walk followed by an indoor festival, including some free wellness testing and health evaluations. Registration is \$35 (free for kids). **Breaking Par at Grandezza:** The ECCL and its Education Outreach Council (EOC) are hosting the 7<sup>th</sup> Annual "Breaking Par at Grandezza," benefitting Junior Achievement of Southwest Florida. The Gala Dinner & Golf Tournament are taking place on March 21 & 22 at the Grandezza Country Club. The Golf Shotgun Scramble is sold out, but Gala tickets are still available. <u>Visit the ECCL's website to register or learn more.</u>

**Village Report:** The Village Comprehensive Plan was approved last summer and focuses on quality of life, development of a sense of place and a sense of community. In his report, Councilman Howard Levitan outlines the Village's top ten priorities in the Comp Plan.

**Estero Community & Economic Development Team:** The Estero Chamber of Commerce has organized a Community & Economic Development Team to develop and implement a strategic plan that enhances the overall quality of life within Estero and focuses on community development, business retention and growth, and a strong chamber of commerce.

**Transportation Committee:** The ECCL Committee conducted a survey and held focus group sessions to judge residents' concerns about London Bay Homes' proposed development of the former "Weeks Fish Camp" property, which is located in Bonita Springs on Estero Bay. The Committee is consulting with Estero's Village Councilperson, Bill Ribble, who is Estero's Liaison to Bonita Springs. The Village, the County, and the City of Bonita Springs have contracted for a

Coconut Road Traffic Study to assess current condition, the impact of proposed new developments, and recommendations for improvement. A <u>Bike-Ped Master Plan webpage</u> has been set up to collect community comments on bike and pedestrian issues. The Village approved a plan for a traffic signal on Puenta Lane at Corkscrew Road (Lowe's entrance).

**Fundraising Program:** The ECCL has established a new Finance and Fundraising Committee to help develop initiatives to tap advocacy-related resources, charities and other non-profits, and more. Current ECCL funding sources include dues from member communities and Lee Health, community donations, and digital marketing revenue. The Committee's considering establishing a 501(c)(3) organization and/or establishing a "field of interest fund" and offering charitable gift annuities.

**Estero & San Carlos Park Fire Rescue:** Both San Carlos Park and Estero Fire Rescue are participating in the Annual Muscular Dystrophy Association (MDA) Boot Drive being held March 8-10. Both departments are also preparing for brushfire season. Residents can expect smoke from planned burns at Wildblue on East Corkscrew. Now is the time to begin holding hurricane preparedness programs.


- Both fire districts check the proper functioning of all hydrants twice per year.
- Water districts (Lee County Utilities & Bonita Springs Utilities) are responsible for painting.



# Village Comprehensive Plan

- The plan was approved last summer and is a strategic document that outlines the Village's future development direction.
- It focuses on quality of life, development of a sense of place, and a sense of community.
- The Village strives to be a highly valued place to live, work, and visit





- Vibrant Economic Centers:
- Attractive Landscaping, Streetscaping, Lighting, Signage, & Architectural Features; and
- An Interconnected Transportation Network.

# • Village's 10 Priorities:

- 1. Develop a Village Center to Unify the Community
  - The Village recently purchased 62-acres and much of this land will likely be home to the Village Center.
- 2. Improve Connectivity Between Residential Neighborhoods, Economic Areas, Civic Uses, Parks, and Recreational Facilities
  - An example of improved connectivity is a "Green Ribbon" that could provide the ability to walk and bike to Estero's 3 parks.
- 3. Diversify Economic Base
- 4. Develop Targeted Industry Clusters Like Health Care
  - Facilities such as the medical area at Coconut Crossing (owned by Lee Health) will help address our 3<sup>rd</sup> and 4<sup>th</sup> priority.
- 5. Expand Multi-Modal Transportation Options
  - We will focus on a Bike/Ped Study and Suntrail/Rails to Trails.
- 6. Improve Access to the Estero River



- There is currently limited access to the river. With the recent 62-acre purchase, the Village now owns the Kayak Rental parking lot, one of the two river access areas.
- The river cannot carry all the water that flows into it because of silt from construction upstream. We need to improve the quantity of water flowing into the river and improve flow ways out east.
- 7. Promote Cultural & Historical Resources
  - The center of our historical area is part of the new property acquisition and offers direct connection via the river to Koreshan Park.
- 8. Provide Public Gathering Places
  - Part of the plan includes mixed-use standards in future land use. Our first test case will be Estero Crossing near Lowes.
- 9. Maintain Unified & Consistent Aesthetic/Visual Quality
- 10. Promote Private Investment & Mixed-Use Centers
  - The Village Center is planned to incorporate mixed use, which means higher density to support retail and civic uses, provide connectivity and walkability, and public gathering places.

# LEE COUNTY LOCAL PLANNING AGENCY (LPA); PROPOSED CHANGES IN DR/GR MINING RULES

# Proposed Amendments to the Lee Plan:

- Eliminate the requirement for a lime rock supply inventory and demand analysis.
- Eliminate the need for mines to be designated on Map 14 (Future Limerock Mining Overlay District)
- Delete Map 14 entirely from Plan

# • First LPA Hearing: December 17, 2018

- LPA concurred with eliminating needs assessment analysis.
- LPA asked Lee County staff to provide additional information regarding Map 14 at the next hearing.
- Groups speaking in <u>opposition to proposal</u> included the Conservancy of SW Florida, Sakata Seed, Village of Estero, ECCL, Audubon Society, Cape Coral Friends of Wildlife, Sierra Club, Florida Wildlife Federation, and other residents of Lee County.

#### Second LPA Hearing: January 28, 2019

- Lee County planning staff responded to objections raised at the Dec 17 hearing regarding Map 14.
- Despite additional testimony in opposition to the proposal, LPA voted to favorably recommend the proposal to County Commissioners by 6-1 vote.
- LPA also voted <u>NOT</u> to recommend staff's proposal to increase buffers between mines and residential property lines from 150 feet to 2,000 feet.
- No discussion regarding various suggestions to conduct workshops to obtain input from the public, other professionals, and key stakeholders.

# It was noted during those discussions:

- These amendments are being presented as a way to fix inconsistencies between the Lee Plan and the Plan Code and to streamline the approval process.
- Objections to the current requirement for a need analysis do not pass the reasonability test.
- Objection #1: Why are we treating mining differently than other land uses?
  - Answer: The impacts of mining are clearly more harmful, enduring and irreversible than the impacts of other uses.
- Objection #2: There is no established methodology for determining need.



- Answer: There may be competing methodologies, but that doesn't mean that one cannot be selected after consultation with experts in the field.
- Objection #3: Nobody in their right mind would invest in a mine if the market demand didn't exist and the property for profitability didn't exist.
  - Answer: Yes, but the financial interests of mining operators are not the same as those of the general public. It is possible for Lee County mines to be very profitable by serving a very large geographical market while devastating the quality of life for Lee County residents.
- It was noted that Lee County mines serve 70% of 7 SW Florida counties.
- Prior advisory committees to the LPA:
  - Met 23 times
  - Lee County spent \$1.6M on consultants to ensure policies stood up to legal challenges.

# • What's Wrong with the Proposal? - Summary

- Eliminates the commonsense requirement that the need for new mines be

justified before they are approved.

Map 14 is the result of a "carefully considered, carefully studied process that included experts, the public, staff, stakeholders, and interested parties."

 Map 14 protects wildlife habitat, water resources, and directs mining away from incompatible uses.



- Rather than deleting Map 14 because it is not as effective as it could be, the Plan should be improved by more closely aligning the Map with Lee County code.
- Repeated requests for meaningful dialogue with key stakeholders have been ignored.

#### • Other concerns discussed:

- Environmental Issues:
  - Deep mines routinely dry up adjacent wetlands
  - Reduces water in the aguifer
  - Increases risk of flooding
- Additional truck traffic on already-overloaded Corkscrew Rd.

#### Next Steps

- Spread the word raise awareness
- Critical that County Commissioners understand the gravity of this proposal and how it can negatively impact the quality of life in Estero.
- Unlike with re-zoning proposals, there is no prohibition on contacting County Commissioners.




