

# **ECCL Report: March 2018**

**Executive Summary:** 169th meeting of the Estero Council of Community Leaders



The Village of Estero is celebrating its third anniversary this month with a free, community-wide outdoor concert on March 16. Lee Health is collecting letters of support from Estero community members for their CON application for Lee Health Coconut Point. The Village has also been meeting to prepare for the Zoning Examiner Hearing for the Old Corkscrew Planation Mine. Regarding Corkscrew Road, Commissioner Kiker and Assistant County Manager Doug Meurer stated in a meeting with the ECCL and ECA that

they are going to address improvements to the road in their next CIP and the project will go from a Tier II Unfunded project to a Tier I Funded project.

The next ECCL meeting will be Friday, April 13, 2018 at 10:00 am at Estero Community Park.

## LEE HEALTH CERTIFICATE OF NEED (CON) SUPPORT LETTERS

- Lee Health Special Projects Director Suzanne Bradach
- **Background:** Lee Health made a commitment to bring a hospital to Estero. They purchased land in Coconut Point and filed for CON a few years ago but were denied. They changed direction and decided to build an ambulatory, out-patient facility built to hospital code with intent to add beds when opportunity was available.
- **Update:** In February, Hospital Corporation of America (HCA) filed letter of intent to file a CON for an up-to-100 bed hospital in Lee County (location unknown). If Lee Health didn't do anything and tried to compete for beds in South Lee County, the state could potentially approve the HCA application. If that happened, the chances of Lee Health being able to bring a hospital to Estero would disappear for decades. So, Lee Health decided to file their own letter of intent in the same cycle as HCA.
- CON Timeline:

February 21: Filed Letter of Intent

February 22: Lee Health Board approved CON Filing

March 7: Shell Application Due March 31: Letters of Support Due April 11: Full Application Due June 1: Agency Initial Decision

 When Lee Health filed original CON four years ago, they received the highest number of letters of support ever seen in a CON application. However, the State said that the "cut & paste" letters they received didn't provide good information, stories, experiences, etc. that would justify the need for a hospital. So, Lee Health is changing their approach for the new application. Community letters of support are needed. (Due by March 31, 2018)

- **To clarify:** The letter should be ADDRESSED to the agency in Tallahassee but should be SENT to Lee Health in Fort Myers so they can attach it to their application.
- What to include in your letter of support:
  - 1. Begin letter with who you are & you support Lee Health's CON application
  - 2. Explain personal reasons for supporting the bed request
  - 3. Share details of how a hospital would personally benefit you or a loved one, friend, or neighbor
  - 4. Mention Lee Health's commitment to South Lee County
  - 5. Close with a statement of support and request that CON be approved
  - 6. Include name & contact information at the bottom of the letter
- Lee Health cannot disclose exact details, services, or number of beds (though it will not be more than 160 beds) until after their application is finalized in April. After April 11, Suzanne will come to an ECCL meeting and share exact details of application.
- Ideal goal is 300-400 letters of support (approx. 10 for each Estero community).
- Nick Batos, member of the Village Council and the liaison for Lee Health, has been representing the Village Council in their support of Lee Health.
- Lee Health is a public non-profit & HCA is a for-profit public corporation.
- Asking your community, personal physicians, and board of directors to support Lee
   Health is encouraged & appreciated.
- ECCL's Health Committee believes that one of the major components of maintaining good health is having high quality medical care available, so they expanded their mission to include major support for Lee Health's mission

- Old Corkscrew Planation Mine Application:
  - **Zoning Examiner Hearing** is tentatively planned for **March 27 at 9:00am**.
  - Within about a week, we should expect the county staff's report on the mine application. Peter along with some representatives with the Conservancy & Audubon and a few others are planning a meeting to discuss the findings of the staff report so they can be prepared for the Zoning Examiner Hearing.

- Troyer Brothers Mine Postponement: Comprehensive Plan Amendment (CPA) deadline was pushed to December 3, 2018.
- Florida Environmental Legislation Update
  - **Ban on fracking** was to be voted on today (March 9, 2018).
  - Wetlands Assumption, Bill 7043: State of Florida wants to take wetland regulations away from the Army Corps of Engineers and assign it to the Florida Department of Environmental Protection (FDEP). This is a terrible idea. Currently, the issue is counter-balanced between federal and state. With this new bill, all of the power will be put with the state, which is highly politicized. We also know that the FDEP has been eviscerated by the Scott Administration but will have to take on a large new program with no new staff or new budget. Both houses of the legislature have passed this, but Governor Scott hasn't signed it (though it indicates that he will). We're asking that people contact Governor Scott and tell him no on this bill.
  - **Florida Forever:** One-year allocation for fiscal year 18-19 of \$100.8 million. This is down from \$300 million a few years ago, but better than it was last year.
  - Omnibus Growth Bill, HB 883: Any land within 3 miles of a state university, no matter how it's classified in terms of zoning, must be included as urban use, only

- applies to Counties with urban growth boundaries so FGCU not affected. Passed House, Senate decides today.




#### TRANSPORTATION REPORT

- Bob King

#### • Lee County Transportation Needs:

- Capital Improvement Plan (C.I.P.)
   Amendments do not currently include any improvements on Corkscrew Road, relative to the four-laning.
- There was a meeting yesterday (March 7) by members of the ECCL and the ECA with Commissioner





- 1. They're going to prepare the input for the next CIP & it will contain the improvements on Corkscrew Road. It's going to go from a Tier II Unfunded project to a Tier I Funded project.
- 2. The County is putting together a website that they hope to have available by the end of the month that will have updates on projects.
- 3. The "Complete Streets" concept will be considered. (Complete Streets incorporates things like heavy landscaping, narrower streets, bike paths, etc. to help slow down traffic.)

#### • C.A.C. Report:

- **Estero Bike:** \$100,000 study to select vendor by June, then that will proceed to create a Bike/Pedestrian Master Plan for the Village.
- M.P.O. Impact Fee Discussion: Not a normal CAC discussion topic, but will be made an agenda item in April.

#### AIM Traffic Study:

• Completed 5 tasks & presented the information in December 2017 to discuss the needs for improvement to Corkscrew Rd. Now, we move onto Tasks 6-8 which deal with how much it's going to cost & who will pay for it.



- Task 6: Transportation Improvement Cost Estimates (Meetings with AIM to Modify Initial Findings)
- **Task 7:** Environmental Support Environmental study is progressing but slowly because they're claiming that it has expanded dramatically in scope.
- Task 8: Proportional Share Analytics Proportionate Share Determination combined with Impact Fees and several other sources will provide the money that will be used to widen the road.
- Task 9: Public Involvement There's only been one meeting so far. Don't know when the next meeting will be held because they're still trying to finalize Task 6.
- County website will include updates about the AIM Study.
- The next Transportation Committee Meeting will be on March 15 at 9:30am at Fine Mark Bank.

## IMPACT FEES: SCHOOLS, FIRE DISTRICT, & COUNTY TRANSPORTATION

- The county has been trying to diminish the use of impact fees and rely exclusively on the four other sources that are available.
- Report on the Board of Commissioners Hearings to Date:
  - 45% to continue (\$8,478 in impact fees on a single-family home, currently \$6,138)
  - Annual Escalator of 2.5% added each year for 5 years.
  - 100% rate slated for EMS and fire protection.
  - Added new categories to the impact fee schedule (senior care facilities and three categories of restaurants)
- County Focus on Lee County Transportation
   Capital Improvement Plans (CIP):
  - CIP Process: 10-year-plan where you plan what you'll spend on road projects each year for the next 5 years and then, as a lump sum, the next five years. With that, the county can identify their estimated amount of revenue without telling anyone what that is. Then, they can allocate it to their preferred projects which benefit them from a political perspective. (Substantially restricts public input)
  - Only 10% of the CIP money might be available for new projects.



#### **COMMUNITY PLANNING**

- Projects in Development Review Process:
  - 4 Hotels
  - 2 Assisted Living Facilities
  - 70,000 sq. ft. Office Building
  - 2 Multi-Family Apartment Sites
  - Commercial Retail Shops across from Walmart
  - Lee Health Coconut Point
  - Genova Condos
  - Estero Parkway Upgrades
  - Village has approved a study of engineering so that they will improve the landscaping on 41 from Corkscrew to Coconut Point.



- Statistical study of what's happening in local real estate.
- Last year, Lee County had a 3/10 of 1% reduction in the number of residential units that were built. Estero and Bonita Springs had 2.3% less growth than the year before. (This is good & shows normal, steady growth.)
- Land is being purchased for future growth by all of the big home builders in the surrounding Estero area.
- Edison Farms was purchased.
- Big box stores (like Sports Authority in Coconut Point) are going out of business.

#### **FINANCIAL REPORT**

- Bob Lienesch
- \$350 of Residential Community Dues paid in February. Collected most of the dues for 2018 last year.
- Almost all communities are now paid except for 4 (2 of those 4 are in process, the other 2 we're having trouble contacting).
- Expenses typically run about \$1,000/mo (mostly Communications costs).
- For the month, we had an excess of expenses of \$928.
- YTD: We are \$1,431 positive (only because dues are received early in the year and expenses are incurred later in the year).
- Cash at February 28 was \$18,012. This is an adequate amount at this time.
